PURPOSE OF JOB:

To undertake practical survey, monitoring and conservation work as part of the Lough Neagh Partnership 'Lough Neagh ASSI Management' project aimed at restoring favourable status to the Lough Neagh SPA, ASSI. This will include survey, monitoring and habitat management on Lough Neagh islands breeding bird sites and shoreline sites including Killycolpy, Killywoolaghan, Reas Wood & Farrs Bay SAC, and the School Lands at Derrytresk and Derrylaughan.

KEY DUTIES:

- 1. Delivery of ASSI Management project on the Lough Neagh islands and other sites around the Lough Neagh shoreline
- 2. To undertake habitat, bird, flora, fauna, and invertebrate habitat surveys (e.g. WeBs surveys, heronry surveys, Northern Ireland seabird and curlew surveys. *NB: Some of these will be undertaken by boat*).
- 3. To upload data to CEDaR website and to share with colleagues from DAERA, NIEA and other organisations on request.
- 4. Habitat management and, if appropriate and consented, management of predator control activities.
- 5. To provide survey reports (habitat, invertebrate, birds, etc)
- 6. Stakeholder engagement to liaise with landowners, farmers, fishermen, sand traders, wildfowlers, community, marina, and other recreational users as/if required.
- 7. To develop, organise and supervise a volunteer network and volunteer events.
- 8. Boat handling, boat, and habitat management equipment maintenance.
- 9. To provide risk assessments for all activities as required and to ensure compliance with health and safety requirements and to ensure these are signed off by the Line Manager.
- 10. Preparation and submission of applications for consent/ wildlife licence to DAERA/ NIEA. To ensure consents are in place for all proposed survey, monitoring and habitat management work and that all works comply with the conditions of any consent granted.
- 11. To liaise with and assist other members of the Lough Neagh Partnership (LNP) team as required.
- 12. To undertake representational duties for the Lough Neagh Partnership If required.
- 13. To assist with media engagement as/when required.
- 14. Any other duties as required.

- Knowledge of Lough Neagh designations, its wildlife and feature species

- Physical ability to undertake heavy manual labour in an outdoor environment.

- Data analysis and report writing skills.
- Good communication skills and ability to deal with members of the public.
- Current driving license and access to own transport.
- IT skills (competent user of Microsoft Office)
